



**Booking a portrait session with Amber Dawkins Photography signifies your acceptance of the following terms:**

1. Our process starts with a consultation meeting before the session is booked. At this meeting, we will discuss ideas and plans for the session, including location, style, wardrobe, and special requests. Session details may change later at the request of the client or photographer due to personal circumstances or inclement weather.
2. Session payment is due in full on the day of the session. Part of this total is subject to sales tax. At the time of booking, session prices and associated costs are as follows:
  - a. One hour family, senior, or child portrait session with 30 digital images, **limited resolution**: \$550
  - b. One hour family, senior, or child portrait session with 30 digital images, **full resolution**: \$750
  - c. Lifestyle newborn session with 30 digital images, **limited resolution**: \$750
  - d. Lifestyle newborn session with 30 digital images, **full resolution**: \$950
  - e. Add on Options
    - Extra 30 minutes - \$75 (mandatory for extended families)
    - Additional 15 digital photos - \$100
    - Mid-session location change - \$50
    - One full resolution photo with full print rights - \$100
3. **Limited resolution** images can be printed up to size 8x10. The client agrees to adhere to these print conditions. Amber Dawkins Photography is not responsible for loss of quality in prints larger than 8x10.
4. **Full resolution** images will print in high quality at all sizes.
5. Packages include a web optimized copy of each image for use on social media. These images are watermarked with a small logo.
6. Digital images are not to be altered by the client. Cropping, further editing, or changing these images in any way is prohibited so as to preserve a style of photography that is consistent with Amber Dawkins Photography's name and reputation.
7. In the unlikely event of equipment damage, loss, or theft resulting in the loss of digital product before delivery, Amber Dawkins Photography will work with the client to reshoot the session in full or in part. Should the client choose, a full or partial refund may be obtained instead. Amber Dawkins Photography will not be held liable beyond these measures.

9. Resale of images is prohibited.
